Food Safety Committee (Rules and Regulations)

Implementation of The Food Safety and Standards Act, 2006 at Rajiv Gandhi College of Engineering and Technology (RGCET), Puducherry:

<u>Understanding the Act:</u> The first step in implementation is to thoroughly understand the provisions of The Food Safety and Standards Act, 2006 (FSS Act). This includes sourcing ingredients from reputable suppliers, inspecting food items upon delivery, and maintaining proper storage conditions to prevent contamination.

Hygiene and Sanitation: RGCET maintains strict hygiene and sanitation standards in the canteen premises. This includes regular cleaning and disinfection of cooking equipment, utensils, and food preparation areas, as well as proper waste disposal practices to prevent crosscontamination.

Regular Inspections and Audits: RGCET conducts regular inspections and audits of the canteen facility to ensure compliance with the FSS Act and identify any potential food safety hazards. These inspections may be carried out by internal food safety officers or external regulatory authorities as required.

Record Keeping and Documentation: RGCET maintains comprehensive records and documentation related to food safety practices, vendor licenses, procurement processes, inspections, and audits.
